Public Information Guide: Palisades Fire

Update: January 13, 2025, 6:30 PM

Current Fire Status (source: CalFire):

- **Size:** 23,713 acres
- **Containment:** 14%
- **Structures:** CalFire now estimates approximately 5,000 structures damaged or destroyed. 1,280 structures confirmed destroyed in **total effected area (Palisades and Malibu)**. Damage assessments continue to determine how many homes are part of the estimated damaged structures. These are approximate numbers, subject to change. <https://recovery.lacounty.gov/palisades-fire/>
- **Damage Assessment:** Malibu Building inspectors are conducting rapid visual assessments; number of damaged/destroyed structures within City limits TBD
- **Injuries:** 3* (Per CalFire Report)
- **Fatalities:** 3 in Malibu per LA County Medical Examiner News Release, 8 total (CalFire)
- 6 missing residents per LA County Sheriff
- **Fire Limits:** At this time, the fire footprint has not grown within City limits, stopped at Franklin Fire burn scar. Extreme hazards remain within evacuation area.
- **Weather Conditions 1/12/25 4:57 PM (Source: NWS): RED FLAG WARNING, PARTICULARLY DANGEROUS SITUATION (PDS)**
 - Weather Service Warning - Tuesday 4 am to Noon Wednesday – 45 to 70 MPH winds possible – weather.gov/losangeles for more info
 - 58 degrees, winds NE to NW at 7 MPH, with gusts up to 20 MPH. Winds could increase to 25 to 30 MPH in the evening with gusts up to 45.
 - Humidity of 15%. – Reported from the Topanga weather station

During this emergency response period, city operations are temporarily modified to prioritize public safety and critical infrastructure needs. Essential services will remain active, with key personnel continuing to address urgent matters while non-critical departments are not actively operating.

City Information Distribution:

- The City is establishing multiple information distribution points throughout Malibu to ensure residents have access to the latest updates and resources.
- Residents are encouraged to check with these locations for critical information if connectivity remains limited.

Resident Access / Escorts into Closed Areas:

LAPD and LASD have suspended all escorts due to victim recovery operations.

Trash Collection Services:

- **Universal Waste Systems (UWS)**

- UWS is still unable to access service areas in Malibu, including Malibu Road, due to road closures.
- UWS will collect trash as soon as access is allowed.
- UWS plans to attempt trash collection tomorrow.
- Resident Instructions:
 - UWS encourages residents to continue bagging trash.
 - To avoid hazards during high winds, residents are advised to secure trash cans and pull them inside.

- **Waste Management (WM)**

- Waste Management serviced residential Thursday routes as per the regular schedule, covering areas from Heathercliff through to Trancas Canyon.
- Commercial routes are proceeding as planned, with the exception of areas impacted by the Malibu Canyon and Topanga closures, including the Civic Center area.
- To keep residents informed, Waste Management has utilized their Outdial System to notify customers of any disruptions.

Santa Monica - Malibu Unified School District

- All Santa Monica schools except Roosevelt Elementary, which is still in evacuation warning zone will open Monday, January 13. Malibu schools will remain closed Monday, January 13 Tuesday, January 14 and Wednesday, January 15. A decision will be made regarding Thursday, January 16 and Friday, January 17.

EV Charging available in Civic Center area

Southern California Gas (SoCalGas):

Social Media update with info from SoCalGas posted on socials at approx. 1730 on 1/12/2025

- Restoration is in progress by the local gas company, the process to restore safely is lengthy but we need to be safe to not cause added risk
- SoCalGas is actively monitoring multiple fires in Los Angeles County, including the Palisades Fire in Pacific Palisades/Malibu, Eaton Canyon Fire in Altadena/Pasadena, and Hurst Fire in Sylmar.
- Crews are coordinating with first responders and standing by to assess impacts.
- **Service Impacts:**
 - The gas main has been shut off from **Neptune's Net to Topanga**.
 - Natural gas service has been temporarily shut off to the Malibu community, from Brentwood Country Club to Pepperdine University. Approximately 15,000 customers are currently affected.
 - Gas service will be restored once it is safe to do so. SoCalGas may need to shut off service in additional areas for public safety.
- **Customer Guidance:**
 - Customers should not attempt to restore gas service on their own. SoCalGas crews will assist with service restorations.

- **Restoring service requires an in-home safety check**, and an adult must be present. Please allow access to SoCalGas personnel to gas meters to expedite the restoration of gas service.
- Customers will not be billed for gas service during the outage.
- Flexible payment arrangements and bill forgiveness may be available for customers directly impacted by fire damage or displacement.

Telecommunications:

T-Mobile: 8 towers operating. Working on 4 being assessed for damage. 1 COW at Malibu High and Middle School. 1 COW being deployed at Malibu Elementary School, Charging Station at Malibu High School.

T-Mobile: has full coverage in the west side of Malibu (west of Nobu).

AT&T: SatCole and generators stationed at Zuma and Will Rogers State Park for emergency personnel use only 1/8.

All major network facilities remain online with some running backup power. Mobility teams continue to dispatch where it is safe to do so; however, fire areas and evacuation zones will not be accessible until conditions improve.

Verizon: Generators on cell towers at Civic Center and Zuma Beach. Community mobile trailer at Ralphs with public charging, Wi-Fi and access to TVs.

KBUU – Operational

EOC has tentative plans to deploy Wi-Fi trucks to Trancas Country Market, Malibu Elementary, Malibu High School and Malibu Bluffs Skate Park. Exact timing TBD.

A Mobile Charging Station for cell phones and small devices will be available in Malibu Bluffs Park and Pavilions on Point Dume. Please adhere to curfew restrictions 6:00 PM- 6:00 AM

Do Not Drink Water Advisory: The Los Angeles County Waterworks District No. 29 (LACWD) and the State Water Resources Control Board - Division of Drinking Water have issued a mandatory DO

NOT DRINK NOTICE for the eastern portion of the City of Malibu up to and including Carbon Canyon and the community of Saddle Peak in Topanga due to potential of fire-related contaminants that may have entered the water system. Affected customers are urged not to drink or cook with the tap water until further notice.

Unhealthy Air Quality Declared due to Palisades Wildfire: The South Coast Air Quality Management District, has declared unhealthy air quality from the Palisades Fire Event, impacting northwest coastal Los Angeles County including Malibu, Pacific Palisades and areas near the fire.

- The Los Angeles County Department of Public Health has issued an urgent health order, effective immediately, to address the potential health risks associated with fire ash, smoke, and particulate matter resulting from the ongoing Critical Fire Events and Windstorm conditions. As part of this order, the use of all powered air blowers, including electric and battery-operated leaf blowers, is strictly prohibited across the County. This restriction applies to all areas within the County.
- The following recommendations will help you protect yourself and your family from harmful effects of bad air quality:
- Stay indoors to limit exposure, especially if you have heart or lung conditions, are elderly, or have children.
- Keep indoor air clean by closing windows and doors. Use air conditioners that recirculate air to filter out harmful particles. Wear an N95 or P100 mask if you must go outside in smoky conditions for long periods of time in areas with heavy smoke or where ash is present.
- Avoid using fireplaces, candles, or vacuums. Clean dusty surfaces with a damp cloth and don't smoke.
- Avoid leaving your pets outdoors, particularly at night. Pets should be brought into an indoor location, such as an enclosed garage or a house.

Repopulation: No repopulations efforts are expected to be scheduled for at least the next 72 hours.

Crime: The Los Angeles County Sheriff’s Department is firmly enforcing mandatory evacuations orders. A misdemeanor will be issued to anyone found in an area that is subject to an evacuation order. Sheriff’s Crime Suppression Unit is conducting active patrols in all evacuation areas.

Curfew in Effect: Currently the Los Angeles County Sheriff’s Department is now enforcing a curfew that began at 6:00 pm and will continue to 6:00 am curfew in evacuation zones. Currently no persons, including residents, are being allowed to re-enter the mandatory evacuation zones.

City Updates:

- **City Hall:** Closed.
- **Programs:** All City programs are canceled.

Key Messages for Residents:**1. Evacuate When Ordered:**

- Evacuation orders save lives. If you are told to leave, do so immediately.
- Close all windows and doors, move flammable items away from your home, and leave doors **unlocked** for firefighter access.
- **No person is authorized within the evacuation zone, including insurance representatives, contractors, debris removal contractors. This area has active hazards and is only available to public safety officials.**

2. Stay Informed:

- Power outages are affecting alert systems. Residents must tune into **KBUU 99.1 FM** for real-time updates.
