Public Information Guide: Palisades Fire

Update: January 23, 2025, 5:00 PM

Current Fire Status (source: CalFire):

- **Size:** 23,448 acres (lower number due to better mapping)
- **Containment:** 72%
- **Structures:** CalFire confirmed 6,662 structures destroyed and 890 damaged in total affected area (Palisades and Malibu). Damage assessments continue to determine how many homes are part of the estimated damaged structures. These are approximate numbers, subject to change.
- **Damage Assessment:** Malibu Building inspectors are conducting rapid visual assessments; number of damaged/destroyed structures within City limits TBD. 94% of inspections completed for the fire incident.

- **Injuries:** 3* (Per CalFire Report)
- **Fatalities:** 3 in Malibu (LA County Medical Examiner), 11 total (CalFire)
- **Missing:** 6 (LA County Sheriff)
- **Fire Limits:** At this time, the fire footprint has not grown within City limits, stopped at Franklin Fire burn scar. Extreme hazards remain within evacuation area.

- **Current Weather Forecasts (Source: NWS)**
 - Wind Advisory until 6:00 PM tonight, Thursday, January 23
 - Red Flag Warning through 10:00 AM on Friday, January 24
 - Malibu City staff are closely monitoring the current wind and weather conditions, collaborating with partner agencies to prepare the community. Fire, law enforcement, and utility resources from across the state and country continue to be deployed throughout Malibu to ensure safety through the forecasted wind event.
 - The community can take preparedness actions now to remain at the ready: charge/fill up your vehicles, have a go-bag ready for each member of your household; stay informed and register for emergency alerts.

- Weekend Weather:

- A 80-90% chance of rain is expected from Saturday January 25, 2025, through Monday January 27, 2025. Forecast calls for 0.25 to 0.75 inches of rain in the coasts and valleys, and up to 1.50 inches in the foothills and mountains. There is a small chance of thunderstorms, which could result in additional rainfall in localized areas.

Southern California Edison (SCE):

Southern California Gas (SoCalGas): SoCalGas continues to restore service to homes that have not been directly affected by the Palisades fire. Workers today have restored natural gas service to an additional 7 customers in the northwest areas of Malibu, bringing the total number of restored customers to 3,533. For updates visit socalgas.com/fires.

- It is important for customers to know the following about the restoration process when you return home:
 - An adult over age 18 must be present during restoration.
 - To restore your service, SoCalGas must have access to your meter and inside your residence to check the safety of your natural gas appliances.
 - This process will take one to two hours.
 - Never attempt to restore or turn on your natural gas service yourself.

- **Customer Guidance:**
 - Customers should not attempt to restore gas service on their own. SoCalGas crews will assist with service restorations.
 - Restoring service requires an in-home safety check, and an adult must be present. Please allow access to SoCalGas personnel to gas meters to expedite the restoration of gas service.
 - SoCalGas Customer Service 1-800-427-2200, available 24/7 for information or to report a gas leak.

LA County Waterworks District No. 29:

- **Do Not Drink Water Advisory:** The Los Angeles County Waterworks District No. 29 (LACWD) and the State Water Resources Control Board - Division of Drinking Water have issued a mandatory DO NOT DRINK ORDER for the eastern portion of the City of Malibu up to and including Carbon Canyon and the community of Saddle Peak in Topanga due to potential of fire-related contaminants that may have entered the water system. Affected customers are urged not to drink or cook with the tap water until further notice.

Telecommunications:

T-Mobile: Most sites restored. Malibu Lake site remains down. Two cell on wheels services are available located at Dukes, Malibu Bluffs Park. Two charging stations are available at Pavilions and Malibu Bluffs Park.

AT&T: All major network facilities remain online with some running backup power. Mobility teams continue to dispatch where it is safe to do so; however, fire areas and evacuation zones will not be accessible until conditions improve.

Verizon: Generators on cell towers at Civic Center to support Incident Command Center.

Spectrum: Internet service has been fully restored west of Carbon Beach Terrace. Personnel working on restoring any remaining impacted areas.

Community Charging Stations and WiFi: T-Mobile Charging Stations for cell phones and small devices are available at Malibu Bluffs Park and Pavilions on Point Dume.

Traffic Signal Status: All signals operational within Malibu City limits. Drivers are urged to treat any dark signals as four-way stops and proceed with caution.

Curfew in Effect:

FEMA - Start Your Disaster Recovery with These Steps:

If you've been impacted by the Palisades Fire, FEMA recommends filing your insurance claim as the first step in your recovery process. Once you've filed with your insurer, FEMA may provide assistance for disaster-related costs not covered by your policy. These can include temporary housing, home repairs, and even help with uninsured vehicle damage.

- The deadline to apply for FEMA assistance is March 10, 2025. Act now to ensure your recovery journey stays on track.

Red Cross Financial Assistance:

Community Services Status:

City Updates:

- **City Hall:** Closed
- **Programs:** All City programs are canceled.

- **Parks:** Charmlee Wilderness Park and Trancas Canyon Park are closed due to Red Flag conditions. Malibu Bluffs Park, Temporary Skate Park, and Malibu Community Pool are closed to the public.

USPS Mail Service: A local Malibu USPS Post Office retail and delivery services has been relocated, and customers are able to pick up mail & packages, submit address changes, and inquire about PO Box services.

Repopulation: (source: genasys & LASD)

There is limited RESIDENT ONLY access to Malibu mandatory evacuation zones MAL-C111-A, MAL-C111-B, and MAL-C112-B.

Pacific Coast Highway between Topanga Beach and Santa Monica remains closed due to the fire response and evacuation order that is in place. Malibu residents should travel from the north, using Kanan Dune Road or Malibu Canyon Road in order to get into the city and check in at the Malibu Pier. Avoid using Las Flores Canyon Road as traffic control points are in place with no access for residents.

The Palisades Fire Incident Management team has announced that Malibu evacuation zone MAL-C111-B is open for RESIDENT ONLY ACCESS, beginning Thursday, January 23, 2025 at 12:00 PM. The evacuation zone east of the City, SSM-U010-A, which includes the Topanga area, is also opening for RESIDENT ONLY ACCESS.

The zones are open for **RESIDENT-ONLY ACCESS**: Newly repopulated residents need to check in at the resident check-in located at the Malibu Pier (23000 Pacific Coast Highway, Malibu). At the resident check-in, residents will receive further instructions from Los Angeles County Fire personnel, be escorted by Los Angeles County Sheriff Deputies to the checkpoint and be allowed access to the repopulated areas. Residents must provide proof of residency. Acceptable forms of identification are a photo ID that displays the resident's name, photo, and physical address. Please have these documents ready to ensure a smooth verification process.

Escorts for newly repopulated zones will be conducted from 12:00 p.m. to 6:00 p.m. On the days following repopulation, residents in the previously opened zones will be permitted to enter at the checkpoint between 6:00 a.m. and 6 p.m. Curfew hours remain in effect.

Department of Public Health staff is distributing health access kits to residents at the Malibu Pier Parking Lot.

How to Prepare:

- As evacuated areas are opened and community members are allowed to return, doing so safely is extremely important. Malibu residents can take steps now to prepare to go back into evacuated areas.

Check the status of your site:

- CAL Fire and the City of Malibu have conducted Damage Inspections (DINS) in wildfire-affected areas.
- Check the preliminary damage assessment map at recovery.lacounty.gov/palisades-fire to view the status of your property. Updates to this map occur daily.
- Color-labels categorize the damage level to each structure:
 - Red: Structure Destroyed (>50%)
 - Orange: Major damage (26-50%)
 - Yellow: Minor damage (10-25%)
 - Green: Structure Affected (1-9%)
 - Gray: Inaccessible
 - Black: No Damage to structure

Precautions for Health and Safety:

- Enter the reopened area during daylight hours. Areas without power will be dark, creating unsafe driving and walking environments.
- Be sure to wear protective gear, such as long-sleeved shirts and long pants, gloves, and sturdy shoes, to reduce exposure to hazardous materials.
- Wear N95 masks and goggles during cleanup to protect against airborne particles. These will be available at traffic control points.
- When approaching a roadblock, residents must provide proof of residency. Acceptable forms of identification are a photo ID that displays the resident's name, photo, and physical address. Please have these documents ready to ensure a smooth verification process.

When at your site:

- Avoid activities that disturb ash, such as using leaf blowers.; instead, opt for gentle wet mopping or HEPA-filter vacuums.
- Be cautious of displaced utility lines and damaged infrastructure. Keep away if you encounter any downed powerline; call the Southern California Edison: 800-611-1911.
- Use bottled water in areas under a "Do Not Drink" advisory.
- Use this time to take video and photos of your property for any insurance claims.

Things to Consider

- **Infrastructure Impacts:**
 - Communities devastated by these fires may likely not have utilities available, even if your property is not damaged. Due to the widespread damage, it was imperative to deactivate electricity and gas services to avoid further damage.
 - Be prepared for extended and potentially intermittent outages throughout these extreme conditions.
- **Water System – Do Not Drink Notice**
 - Los Angeles County Waterworks District 29 has issued a Do Not Drink Notice for the eastern portion of Malibu up to and including Carbon Canyon and the community of Saddle Peak in Topanga due to potential fire-related contaminants in the water system.
 - **Bottled Water Distribution:**

Trash/Waste Information:

- Burned Debris Exclusion: Burn debris cannot be placed in any trash containers. Specialized procedures are required for its safe disposal to protect public health and the environment. LA County is working with the City on a debris removal plan. For questions, please contact the Debris Removal Hotline at (844) FIRE DEBRIS / (844) 347-3332, available Monday through Friday from 7 AM to 7 PM, Saturday from 8 AM to 6 PM, and closed on Sundays and holidays.
- Universal Waste Systems will provide daily trash collection services in all accessible areas within the Malibu Garbage Disposal District through Friday, January 24, 2025. Updates will be provided on next week's service plan after further coordination with UWS on Friday.
- All household trash and food waste can be placed in any available containers. UWS will sort the materials at their facility.
- Boxes and non-hazardous items left at the curb will also be collected. If it's at the curb, UWS will pick it up.
- Residents are asked to place their trash carts and green waste at the end of their driveways for collection.
- Green waste, such as vegetation and yard debris, can be placed at the end of the driveway for pickup.
- If additional carts are needed, contact UWS directly at 800-630-7016 for assistance.
